



# Professional Architectural Corporation Firm Reinstatement Application Instructions

The legislature has enacted laws which govern all firms practicing architecture in Louisiana. In accordance with those laws, the LSBAE has adopted rules which regulate the registration of such firms. All firms practicing architecture in Louisiana are required to register with the LSBAE and receive a Certificate of Authority within thirty days following registration with the Secretary of State. You should consult your legal counsel or CPA regarding the need for business registration with the Louisiana Secretary of State.

To register as a Professional Architectural Corporation, your firm must meet both ownership (shareholder) and control (director) requirements. Your firm must be lawfully incorporated and a majority of shares must be held by a licensed Louisiana architect or by a holding company, of which a majority of shares are owned by licensed Louisiana architects. See [La. R. S. 12:1090](#). In addition, depending upon the number of directors, a majority of the directors must be licensed Louisiana architects. For more information, see [La. R.S. 12:1095](#).

  - 4.2 This option is ONLY for firms where more than one architect owns or holds stock. If so, check the 4.2 box, list the names of Louisiana individually-licensed architects who own or hold stock and the **number** (*not percentage*) of shares owned per architect. You must also show the total corporate shares allowed and issued by the corporation. When 4.2 has been completed, **do not fill out 5. Proceed to 6.**
    - 4.2.1 **For 4.2 firms only.** List ALL DIRECTORS whether or not licensed in Louisiana with their home state and home state license number(s) noted. **Do not fill out 5. Proceed to 6.**
5. **COMPLETE ONLY IF YOUR FIRM'S SHARES ARE HELD OR OWNED BY A HOLDING COMPANY**
  - 5.1 For each owner of the shares of the HOLDING COMPANY, list the names of Louisiana-licensed architects, individual license numbers, and shares owned individually per architect. You must also show the TOTAL number of shares of the HOLDING COMPANY issued and sold to date.
  - 5.2 For each director of the professional architectural corporation, whether licensed as an architect in Louisiana or not, list the names, any individual architect license numbers, and any state of license issuance. If the director is not a licensed architect, so indicate.
6. Please indicate if your firm has practiced or offered to practice architecture in Louisiana without a license. If yes, please list projects.
7. Please indicate if your firm registration has been denied, suspended or revoked in another jurisdiction.
8. Please indicate if the firm has surrendered or allowed its firm registration to lapse due to pending disciplinary action.
9. Please indicate if the firm has been investigated, charged, or disciplined by a governing or licensing state or federal body in the past five years.
10. Please indicate if any licensed architect employed by the firm has had his or her license denied, suspended or revoked or is currently under investigation.

## **FIRM REGISTRATIONS ARE VALID FROM JULY 1<sup>st</sup> – JUNE 30<sup>th</sup> EACH YEAR**

Upon receipt of completed application and the appropriate fee, the professional architectural corporation will have its Certificate of Authority renewed and the firm will be authorized to practice architecture in the state of Louisiana, unless the application is disapproved. This authority will expire on June 30th of the following year unless it is renewed prior to that date. Failure to renew in a timely manner will result in fines and penalties.

Fees: A delinquent fee equal to the renewal fee of \$75 (in-state) or \$150 (out-of-state) will be assessed in addition to the regular renewal fee of \$75 (in-state) or \$150 (out-of-state) for a total of \$150 or \$300, respectively.
